## Welcome and Meeting Overview

Fiscal Oversight Commission Chair Bob Anderson welcomed everyone in attendance and presented the meeting overview.

#### Work Plan Overview

Bill Keene, SCAPOSD General Manager, presented a brief description of the Work Plan process.

## Introduction of the Fiscal Oversight Commission and the District Advisory Committee

Fiscal Oversight Commission Chair Bob Anderson introduced the Fiscal Oversight Commissioners. Advisory Committee Chair Pro Tem Steve Rabinowitsh introduced Advisory Committee Members.

#### Sonoma County Agricultural Preservation and Open Space District 3-Year Work Plan

Bill Keene, SCAPOSD General Manager, provided an overview of the Work Plan process and a brief synopsis of the Stakeholder's Meetings that were held the last week of January and first week of February 2012. Bill indicated that the District was hoping to receive more input from the Advisory Committee and the Fiscal Oversight Commission, as well as the public. A draft of the Work Plan will be on the District's website March 17 that will reflect comments and input that have been received from the Stakeholder's Meetings and the Joint Meeting tonight. The Work Plan will go before the Board of Directors on March 27, 2012, and will be implemented in July 2012 through July 2015.

Mr. Keene provided a brief financial summary as a foundation for the Work Plan. This financial summary will be presented to the Board of Directors on March 13, 2012.

Mr. Keene briefly discussed District priorities, guiding principles, strategies and proposed actions, and the budget detailed in the Work Plan. (See Power Point presentation attached).

#### **Initial Questions/Comments**

Commissioners and committee members had questions related to the funds that make up the budget, e.g., the reserve fund, the Stewardship fund, etc. A discussion of trends over the past several years in sales tax revenue, the impact of reduced revenue on the conservation and stewardship programs, the status of fee lands and maintenance thereof followed.

## Fiscal Oversight Commission/District Advisory Committee Discussion

A discussion of specific properties and the impact of reduced sales revenue continued. Program managers addressed questions and described possible remedies.
