

Buy-Protect-Sell Stage 1 Application

Background

Through our buy-protect-sell pilot, Ag + Open Space will purchase an agricultural property, protect it with an agricultural conservation easement and other protections, and sell it to a farmer, rancher, or other eligible entity. See the program overview for more details.

For this pilot, Ag + Open Space is seeking applicants with moderate to significant agricultural production and business experience. This would typically consist of approximately 5 years of relevant experience, some of which could be achieved through relevant education and qualifications. This stage 1 application will help Ag + Open Space determine whether applicants meet this threshold.

Applicants who meet or exceed this threshold will be accepted into our potential buyer pool. Applicants in this pool will be invited to participate in stage 2 of the application process. Stage 2 will occur once Ag + Open Space has identified the property that we will buy, protect, and sell through this pilot. In stage 2, applicants will develop proposals for this specific property, and one applicant will be invited to purchase the property. See the program overview for more details.

Ag + Open Space currently plans to leave this application open continually until we identify a specific property to buy, protect, and sell.
