Chair Dell'Osso called the meeting to order at 5:04 pm.

Public Comment

Chair Dell'Osso asked for public comments on items not on the agenda.

Duane DeWitt handed out a flyer to the committee referencing the City of Santa Rosa's City Plan for the Roseland Creek Park. His concern is that the City of Santa Rosa wants to develop Roseland Creek into a park rather than a natural preserved area, and the easement states that it would remain as a natural preserve. Mr. DeWitt asked the Committee and District staff to get involved and help the Roseland Creek area to remain as a preserve rather than developed by the City of Santa Rosa.

Approval of Minutes

Chair Dell'Osso asked for any corrections to the December 14, 2017 minutes. There were none, and Jan McFarland motioned to approve the minutes as they were. Tawny Tesconi seconded the motion. All were in favor of approval, with one abstention.

General Manager's Report Out

- John McChesney, Advisory Committee Member, resigned from the committee.
- Bill Keene announced that he would need to leave at 6:30 to attend a Bay Trail Meeting at the Marin Civic Center.
- The Ag + Open Space is sponsoring OpenRoad, hosted by Doug McConnell, that is shown every Sunday evening. Mr. McConnell has been shooting footage of the fire on Calabazas, MarkWest and Cresta properties and will air an episode on community response to the fires. He is also interested in a story that will profile a property or two in the coastal agriculture belt. The Ag + Open Space will keep the Advisory Committee posted about when those episodes will be aired.
- The Matching Grant Program will launch on January 31, 2018. A series of ads are running in local newspapers including the Press Democrat, Argus Courier, Sonoma IT, Sonoma West Times, Windsor Times, and the Healdsburg Tribune. Ag + Open Space are working with our Spanish-language outreach consultant to place ads in several Spanish-language newspapers. The Matching Grant Program will be prioritizing fire areas in Sonoma County this cycle.
- Ag + Open Space has created a new logo (shown on the overhead) and a shortened name that will be simpler and easier to remember and you will start seeing it in our communications, Sonoma County Ag + Open Space. You may see the old logo for a while as we update our materials. We also have a new tagline –LAND FOR LIFE- that speaks to the value our protected lands bring to every living thing here in Sonoma County, as well as the perpetual nature of our land conservation work. We worked with a local creative firm, the IDEA Cooperative, over the last year on these changes.
- Ag + Open Space is holding public meetings for the Vital Lands Initiative in the month of March, the draft will go to the Board on April 17, 2018, and the final will go to the Board on May 22, 2018. More on this process in the update later this evening.

Advisory Committee Administration

a) Election of Committee Officers

Chair Dell'Osso announced that all three of the current committee officers were still interested in their positions, but would step down if anyone else on the committee would like to volunteer. No one came forward. Steve Rabinowitsh motioned to continue with John Dell'Osso as Chair, Don McEnhill as Vice Chair and Curt Nichols as Chair Pro Tem. Bill Smith seconded the motion. There was a vote and all were in favor, no oppositions or abstentions.

b) Advisory Committee Rules of Procedures

Chair Dell'Osso asked for a review of the Advisory Committee Rules of Procedure. There were no suggested changes from the members. Paul Martin motioned to approve the Rules of Procedure as they currently are, and Neysa Hinton seconded the motion. There was a vote and all were in favor, no oppositions or abstentions.

c) Ad Hoc Subcommittee Assignments

No new subcommittees were formed. The current subcommittees are the Agriculture, Matching Grant Program, and Vital Lands Initiative. John Dell'Osso stepped down from the Agriculture Subcommittee and Tawny Tesconi volunteered to take his place. Halie Trowbridge volunteered for the Matching Grant Program subcommittee, and no changes were made to the Vitals Lands Initiative subcommittee.

Mariah Robson, Advisory Committee Clerk, will contact absent members to see if they would like to step down or volunteer for a subcommittee.

d) Committee Calendar and Roster

Chair Dell'Osso asked members to review the calendar dates for meetings in 2018. The members chose July as their summer break.

Subcommittee Report Out

The District currently has three active subcommittees:

- 1. Matching Grant Program
- 2. Agriculture
- 3. Vital Lands Initiative

John Nagle, Agriculture Subcommittee Chair, reported out on their meeting this afternoon at 4:00. They reviewed Living in a Fire-Adapted Landscape: Priorities for Resiliency and had a robust discussion with additional input for Ag + Open Space staff. The subcommittee will be provided with drafts of the upcoming Vital Land Initiative for review and comments.

There was no update for Vital Lands Initiative as there were no meetings since the last Advisory Committee meeting.

Matching Grant Program also did not have any meetings since the last Advisory Committee meeting, and thus no update.

Facility Search

Mary Dodge, Administrative and Fiscal Services Manager, spoke about the Ag + Open Space search for a new facility. Ag + Open Space has been renting its current building for over 15 years. Looking at it from a cost effective standpoint – considering that Ag + Open Space will be working in perpetuity— the rent is expensive. In the long run, owning a building would save money and provide a permanent home. Currently the management team are looking at different options in Santa Rosa, and a two-story building that has been empty for some time at 431 E Street looks promising. It would need to be renovated and an RFP would be generated to find the vendor(s) for the design and construction necessary. Ag + Open Space will write a letter of intent to move forward on this building.

District Land Management Response

Sheri Emerson, Stewardship Program Manager, presented a PowerPoint on the impact of the 2017 North Bay fires. There was significant damage to our properties and we are seeking reimbursement through FEMA for all costs related to the fire.

<u>Living in a Fire-Adapted Landscape – Watershed Collaborative Update</u>

Karen Gaffney, Conservation Planning Program Manager, presented a PowerPoint on the Living in a Fire-Adapted Landscape document and the Watershed Collaborative. The Watershed Collaborative was created a week after the fires in order for groups in Sonoma County to provide input to the County Board of Supervisors related to recovery and resilience actions for the long term, especially focusing on watersheds. This report was prepared by Ag + Open Space, reflecting the priorities of the Watershed Collaborative, and was brought before the Board on January 23, 2018, and was accepted by the Board.

Vital Lands Initiative

Ms. Gaffney also gave an update on the Vital Lands Initiative. There will be community meetings in March to replace those that were cancelled due to the fires. The VLI draft will go to the Board on April 17, 2018, and the final will go to the Board on May 22, 2018.
